



The PEI Humane Society is the Island's only shelter for lost, homeless, abandonned and injured animals.


We are a registered charitable organization that assists over 1,600 companion animals every year.


# A gift you can be proud of

Since the PEI Humane Society's incorporation in 1974, planned gifts have been an important part of ensuring our doors have stayed open.

Our supporters have made it possible for us to continue to develop and provide programs aimed at advancing animal welfare for our Island community.

Planned gifts make it possible for our shelter care team to purchase the supplies needed to offer individual care to all of our animals, regardless of their needs. This can be as simple as providing hypoallergenic food, or as specific as paying for a major surgery for an animal before they leave our shelter for their forever home.





# The new wave of giving: Gifts of Securities

Planned gifts are not always donations left in a will, or meant to be delivered after the donor has passed away. In fact, the largest emerging trend in charitable giving in Canada are gifts of securities. These can be given at any time and can make huge impacts on a donor's annual income tax each year.

Gifts of securities can consist of appreciated stocks, bonds, or mutual funds, given to a charity in a donor's name. And because the PEI Humane Society is a registered charity these gifts are eligible for a tax receipt, just like a donation of funds!

The PEI Humane Society works with CanadaHelps to accept gifts of securities. Ask your financial advisor if this option could be right for you.

## Types of planned giving

**Gifts of Securities** - This gift is given at any time and consists of donating appreciated stocks, bonds, or mutual funds to the PEI Humane Society.

**Naming a beneficiary** - Many donors open life insurance policies and list charities as beneficiaries. Other options can include listing the PEI Humane Society as a beneficiary on your RRSPs, RRIFs, etc.

**Percentage Gifts** - In your will, you can choose what percentage of your estate is given to loved ones or to charity. This helps you determine what proportions of your estate go where without needing to worry about how much will be given to each recipient.

**Residual Gifts** - After designated portions of your estate are given to loved ones in your will you can choose that the remainder be given to one or more charities of your choice. Usually, this is listed on your will as a percentage of residuals.

#### Other options include:

- Investing in a charitable gift annuity or a charitable trust
- Leaving gifts of property (land, homes, vehicles, etc.) and/or cash

## How will my gift be used?

Your planned gift can be used to support prgrams, projects and services that are important to you and your beliefs. Your gift can go toward supporting any level of care at PEIHS but we encourage you to pick an area that you feel most strongly aligns with your values.



## **Expanding Our Paw Print**

We are building a brand new, Fear Free animal shelter to house our growing shelter. This project has been needed for over a decade and we're almost there! By supporting this project, you will support animal welfare on PEI for years to come.

#### **Medical Fund**

Each year, the PEI Humane Society spends hundreds of thousands of dollars on surgeries, including spay and neuter procedures, amputations, and other needs. These surgeries are central to our work and both improve quality of life for our animals and help control the pet population.

#### Safe Haven

Safe Haven offers free temporary housing for pets whose owners are in crisis. This program is offered free of charge to Islanders in need and allows those in need to get back on their feet and retain ownership of their pets.

## **Operations**

Day-to-day operations at the PEI Humane Society cost over \$1,000,000.00 each year. Supporting operations helps us meet the immediate needs of our work each and every day.

The PEI Humane Society recommends that you seek professional advice to ensure your financial goals are considered, your taxes are reviewed, and any planned gifts are tailored to your personal circumstances and desires.

# Your gifts support our work at all levels: Palliative Care

Tasha came to our shelter in February in 2023 and she is still living happily in our palliative foster care program thanks to donors just like you. Despite her age, some incontinence, and some mobility issues, Tasha is living happily in her foster home an will continue to do so for the remainder of her days.

To administer this program, PEIHS works with caregivers and veterinarians to help reduce the burden of stress and suffering for animals that are approaching the end of their lives.

All animals in our Palliative Care Foster Program will have all their needs covered by the PEI Humane Society. Food, medications, and supplies are provided by our organization to ensure that animals in this program are provided the dignified and pain-free end of life we believe they deserve.

In an increasingly demanding and challenging climate, palliative pet care is an invaluable resource for safeguarding and protecting the wellbeing of companion animals.

Animals in this program are terminally ill or else are approaching end of life. When it is determined that their quality of life has diminished, we will provide a humane end-of-life procedure at our shelter to ensure they do not suffer. While they still have quality of life, they will remain in foster care, monitored by our dedicated staff and volunteers to ensure they know that they are loved and looked after.
